

CULLMAN CITY COUNCIL MEETING ON JUNE 6TH, 2018 IN THE LUCILLE N. GALIN AUDITORIUM

Council President Pro Tem Jenny Folsom called the Cullman City Council Meeting in the Lucille N. Galin in Cullman City Hall to order at 7:06 o'clock p.m. on Wednesday, June 6th, 2018.

RESOLUTIONS, ORDINANCES, ORDERS & OTHER BUSINESS

Council Member Page made a motion to adopt the following resolution:

RESOLUTION NO. 2018 - 56

WHEREAS, the City of Cullman has submitted for grant assistance from FEMA to repair the soccer fields in Heritage Park which was destroyed by the March 2018 Hailstorm; and

THEREFORE, in accordance with FEMA regulations the City of Cullman has solicited and received bids from qualified contractors to repair the soccer fields in Heritage Park which was destroyed by the March 2018 Hailstorm;

NOW THEREFORE, BE IT RESOLVED, that the City of Cullman and Kyle Clark of Cullman City Parks and Recreation has evaluated the bids received and has determined that Jerry L. Johnson & Associates, Inc. is the lowest responsible bidder in the amount of \$375,579.00 for the repair of the soccer fields in Heritage Park; and

THAT, Woody Jacobs, Mayor, be and is hereby authorized to enter a contract with Jerry L. Johnson & Associates, Inc. in the amount of \$375,579.00 to repair the soccer fields in Heritage Park which was destroyed by the March 2018 Hailstorm.
