Dr. Scott Warner requested the council consider amending the city's 'clean air' Ordinance No. 2005-19 to prohibit the use of electronic cigarettes in the same places as tobacco smoke. Electronic cigarettes did not exist at the time of the ordinance's adoption, therefore e-cig have created a loophole. The e-cigarette's vapor chemicals create health concerns for the user as well as secondhand inhalation. These devices are also found to spontaneously combust, creating additional dangers.
