WHEREAS, the City Council of the City of Cullman recognizes that in times of significant emergency, resources, equipment, and trained personnel from across Alabama may be required to best mitigate the emergency; and

WHEREAS, the Alabama Association of Fire Chiefs has developed a Mutual Aid Consortium to provide for the coordination of sharing available resources across jurisdictions in times of need; and

WHEREAS, the City Council of the City of Cullman recognizes and agrees that it is in the best interest of the citizens served City of Cullman Fire Department, and the mutual interest of the citizens of Alabama to enter into agreements whereby fire departments will provide fire and emergency support and assistance in the event of significant events or incidents.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CULLMAN, ALABAMA that the Alabama Association of Fire Chiefs Mutual Aid and Consortium Agreement shall become effective upon the passage of this Resolution.

SECTION 1.
