RESOLUTION NO. 2022 – 110 AUTHORIZING THE MAYOR TO PURCHASE REAL PROPERTY

WHEREAS, the City of Cullman has an opportunity to purchase property located near Industrial Park V for economic and industrial purposes and is described as follows:

Parcel I: (Deed Book 133 Page 489)

A parcel of land in the West half of the Northeast quarter of the Northwest quarter of Section 7, Township 10 Range 2 West, more particularly described as follows. Beginning at the Northeast corner of the above described twenty acre tract, thence running south, along the east line of above described tract, to the west side of the Alabama Highway 31, thence in a Southwesterly direction along said Alabama Highway 31, to a road leading off northwesterly, thence along said road North 73 degrees West 252 feet more or less to the Southwesterly corner of the lands which were conveyed to EJ Denson from C Teichmiller, and wife, as of December 16, 1925, see Deed Book 83 at page 288, thence north 1 degree East 967 feet to the north section line, thence East along and section line 323 feet more or less to the northeast corner of above described tract and point of beginning. ORDINANCE NO. 2022 – 30

TO ANNEX CERTAIN PROPERTIES INTO THE CITY LIMITS OF THE CITY OF CULLMAN, ALABAMA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CULLMAN, ALABAMA, AS FOLLOWS:

SECTION 1. The City Council of the City of Cullman finds that the following property owners, Takayah and Amy Johnson, have petitioned the City under the provisions of Section 11-42-21 of the Code of Alabama, 1975, as amended, that the following described property, owned by the petitioners, be annexed into the City of Cullman:

PPIN: 20815. Parcel No.: 17-03-05-4-012-036.000. Property Address: 1742 Lake David Drive NW, Cullman, AL 35055. Legal Description: Lot 4 of a proposed re-subdivision of Lots 3, 4, & 5 of the Second Addition to Ragsdale Subdivision, Map Book 5, Page 197.

SECTION 2. That the Council has before it a map showing the relationship of the property proposed to be annexed to the corporate limits of the City of Cullman, and that said map is on file in the office of the City Clerk along with an acknowledgment by the property owners that they want it to be annexed into the City of Cullman.
