

**CULLMAN CITY COUNCIL MEETING  
MONDAY, DECEMBER 4, 2023, AT 7:00 P.M.  
IN THE LUCILLE N. GALIN AUDITORIUM**

Council President Jenny Folsom called the Cullman City Council Meeting to order at 7:04 p.m. on Monday, December 4, 2023. Fire Chief Brian Bradberry led the Pledge of Allegiance and presented the invocation.

A roll call by City Clerk Wesley Moore reflected the following: Present - Council President Jenny Folsom, Council Member David Moss, Council Member Brad Smith, and Council Member Clint Hollingsworth. Also present were Mayor Woody Jacobs, and City Clerk Wesley Moore. Absent were Council President Pro Tem Johnny Cook, and City Attorney Roy Williams.

Council President Jenny Folsom asked the Council to consider the minutes from November 27, 2023. Council Member Moss made a motion to suspend the rules to consider the minutes. **TO ENTER INTO AGREEMENT WITH THE STATE OF ALABAMA FOR THE INSTALLATION, OPERATION, AND MAINTENANCE OF THE TRAFFIC SIGNAL AT US 278 AT I-65 IN THE CITY LIMITS OF CULLMAN, ALABAMA**  
BE IT RESOLVED, by the City Council of the City of Cullman, Alabama as follows:

1. That the City of Cullman, Alabama, enter into an agreement with the State of Alabama, acting by and through the Alabama Department of Transportation for the installation, operation and maintenance of traffic signal on US-278/SR-74 at the I-65 southbound ramp in the city limits of Cullman which agreement is before the Council.
2. That the Agreement be executed in the name of the City, by its Mayor, for and on its behalf;
3. That the signature of the Mayor be attested by the City Clerk and that the seal of the City be affixed to the agreement.

BE IT FURTHER RESOLVED, that upon the completion of the execution of the Agreement by all parties, that a copy of such Agreement be kept on record by the City Clerk.

**ORDINANCE NO. 2024 – 03**

**AMENDING THE CURRENT ZONING ORDINANCE AND ZONING MAP OF THE CITY OF CULLMAN, ALABAMA, TO RE-ZONE CERTAIN PARCELS OF PROPERTY AS SET FORTH HEREIN**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CULLMAN, ALABAMA, AS FOLLOWS:

SECTION 1. Under the authority of Chapter 52, Articles 1 through 4, Section 11-52-1 through Section 11-52-84, Code of Alabama 1975, as amended, and specifically Sections 11-52-77 and at the request of property owner, the petitioner, the following describe the tracts or parcels of land, to-wit:

Property Owner: N31, LLC.

Parcel 1: Lot 3A. Legal Description: A tract or parcel containing 141.81 acres of land, more or less, and being known as Lot 3A of the Resurvey of Lot 3 (Future Development) of the Plat of Lot 5, of the Re-subdivision of Lot 3, Noble Ridge Subdivision as recorded in the Plat Records of Cullman County, Alabama, and is hereby changed from B-3 Business District and M-1 Manufacturing District to R-4 Residential District.

Parcel 2: Lot 6. Legal Description: A tract or parcel containing 4.24 acres of land, more or less, and being known as Lot 6 of the Resurvey of Lot 3 (Future Development) of the Plat of Lot 5, of the Re-subdivision of Lot 3, Noble Ridge Subdivision as recorded in the Plat Records of Cullman County, Alabama, and is hereby changed from B-3 Business District to R-4 Residential District.

Parcel 3: Lot 7. Legal Description: A tract or parcel containing 15.16 acres of land, more or less, and being known as Lot 7 of the Resurvey of Lot 3 (Future Development) of the Plat of Lot 5, of the Re-subdivision of Lot 3, Noble Ridge Subdivision as recorded in the Plat Records of Cullman County, Alabama, and is hereby changed from B-3 Business District to R-4 Residential District.

within the city limits of Cullman, Alabama, and lying and being in Cullman County, State of Alabama, designated as R-4 Residential District on the Zoning Map of the City of Cullman, Alabama, under Ordinances No. 2004-03 and as may be reflected in any comprehensive master plan for the City of Cullman, Alabama, be, and is hereby changed from B-3 Business District and M-1 Manufacturing District to R-4 Residential District.

SECTION 2. That this ordinance be published at least once a week for two consecutive weeks in advance of its final passage in a newspaper with general circulation within the City of Cullman, Alabama, the first publication of said notice and ordinance being verbatim and the second publication either verbatim or synopsis, with the last publication being at least 15 days prior to the date set for public hearing and passage of said ordinance.

SECTION 3. That a public hearing be held relative to the passage of this ordinance on the 27<sup>th</sup> day of November, 2023 at 7:00 p.m., at which time interested parties and citizens shall have the opportunity to be heard concerning said ordinance and any changes relating thereto.

SECTION 4. That all notices as required by law be given by the City Clerk concerning said public hearing, and in addition thereto, a certified letter be sent by the Clerk to all contiguous property owners at their last known addresses as shown by the tax records for the City of Cullman, Alabama.

SECTION 5. That upon final passage of this ordinance, all zoning maps, master comprehensive plans or any other documents of the City of Cullman, Alabama, in conflict with this ordinance are hereby changed and amended to reflect the changes and amendments herein.

SECTION 6. Should any part or portion of this ordinance be held invalid, unenforceable or unconstitutional, for whatever reason, by a court of competent jurisdiction, such ruling shall not affect any other part or portion of this Ordinance.

SECTION 7. This ordinance shall take effect and be in force from and after its passage or adoption as required by law, including notice, publication and public hearing, all in accordance with Section 11-52-1, et seq., Code of Alabama 1975, as amended.

**ORDINANCE NO. 2024 – 05**

**AN ORDINANCE OF THE CITY OF CULLMAN, ALABAMA, TO EXEMPT CERTAIN “COVERED ITEMS” FROM THE MUNICIPAL SALES AND USE TAX DURING THE LAST FULL WEEKEND OF FEBRUARY, AS AUTHORIZED BY 40-23-230 THROUGH 40-23-233, CODE OF ALABAMA 1975, GENERALLY REFERRED TO AS THE STATE SEVERE WEATHER PREPAREDNESS SALES TAX HOLIDAY LEGISLATION.**

BE IT ORDAINED BY THE CITY COUNCIL OF CULLMAN, ALABAMA, AS FOLLOWS:

Section 1. In conformity with the provisions in 40-23-230 through 40-23-233, Code of Alabama 1975, providing for a State Sales Tax Holiday, the City of Cullman, Alabama, exempts “covered items” from municipal sales and use tax during the same period, beginning at 12:01 a.m. on the last Friday in February 2024 (February 23, 2024) and ending at twelve midnight the following Sunday (February 25, 2024), **and on the last full weekend of February each year thereafter** until and unless annual participation is rescinded by further action of the council.

Section 2. This ordinance shall be subject to all terms, conditions, definitions, time periods, and rules as provided by 40-23-230 through 40-23-233, Code of Alabama 1975.

Section 3. The City Clerk is hereby authorized and directed to certify a copy of this ordinance under the seal of the City of Cullman, Alabama, and to forward said certified copy to the Alabama Department of Revenue to be recorded and posted on the Department website.

Section 4. This ordinance shall become effective on December 4, 2023.
