

**CULLMAN CITY COUNCIL MEETING
MONDAY, MARCH 18, 2024 AT 7:00 P.M.
IN THE LUCILLE N. GALIN AUDITORIUM**

Council President Jenny Folsom called the Cullman City Council Meeting to order at 7:00 p.m. on Monday, March 18, 2024. Fire Chief Darren Peeples led the Pledge of Allegiance and presented the invocation.
