- B. Internal Revenue Service Rules will be complied with for those driving vehicles not exempted from the fringe benefit guidelines. Exemptions shall include emergency vehicles or service vehicles driven by employees on call.
- C. Employees who live more than thirty (30) miles from his or her place of work shall reimburse the City for the mileage in excess of thirty (30) miles at the prevailing rate paid to employees driving a private vehicle on city business with the reimbursement to be deducted from the employee's salary.
- D. Take-home vehicles must be authorized by the Mayor each year.
- Section 2. This resolution shall be effective on May 6, 2024.
