**RESOLUTION NO. 2025-26**

**APPROVING CHANGE ORDER NO. 1 FOR BULLS CONSTRUCTION GROUP**

WHEREAS, the Cullman City Council awarded the bid for a downtown streetscape improvements along 4<sup>th</sup> Avenue SW from US Highway 278 to 4<sup>th</sup> Street SW and extending west along 4<sup>th</sup> Street SW to the intersection of 5<sup>th</sup> Avenue SW (Grant No. TAPAA-TA24(902)) to Bulls Construction Group in the amount of \$1,086,846;

WHEREAS, the City of Cullman wishes to approve Change Order No. 1 to increase the project cost by \$77,205 for a revised lighting plan; and

THEREFORE, BE IT RESOLVED by the Cullman City Council that the Mayor is authorized to execute Change Order No. 1 which will increase the total cost of the contract with Bulls Construction Group to \$1,164,051.
