CULLMAN CITY COUNCIL MEETING MONDAY, JULY 14, 2025, AT 7:00 P.M. IN THE LUCILLE N. GALIN AUDITORIUM

Council President Jenny Folsom called the Cullman City Council Meeting to order at 7:04 p.m. on Monday, July 14, 2025. Police Chaplain Monte Bridgewater presented the invocation and led the Pledge of Allegiance.

A roll call by City Clerk Wesley Moore reflected the following: Present - Mayor Woody Jacobs, Council President Jenny Folsom, Council President Pro Tem Johnny Cook, Council Member Brad Smith, Council Member David Moss and Council Member Clint Hollingsworth. City Attorney Roy Williams and City Clerk Wesley Moore were also present.

Council President Jenny Folsom asked the Council to consider the minutes from June 23, 2025. Council President Pro Tem Cook made a motion to approve the minutes from June 23, 2025, as written. Council Member Moss seconded the motion, and the motion was approved by a voice vote. Ayes: All. Nays: None.

Council President Folsom welcomed Mr. Roy Drinkard, sharing that he has just celebrated his 105th birthday and shared that he is the oldest living marine. Mayor Jacobs led everyone to sing Happy Birthday to Mr. Drinkard.

ADDITIONS/DELETIONS TO AGENDA

Council Member Moss made a motion to add Resolution No. 2025-63 to move the date of the next city council meeting. Council Member Smith seconded the motion, and the motion was approved by a voice vote. Ayes: All. Nays: None.

REPORTS OF STANDING COMMITTEES

- 1. Public Safety (Fire, Police, etc.) Council Member Brad Smith congratulated Fire Chief Darren Peeples for his appointment by the Alabama State Senate to the Homeland Security Taskforce until November 2026.
- 2. Utilities (Water, Sewer, etc.) Council Member David Moss reported that the Water and Sewer Departments are doing well financially, with reserves at an all-time high and without having any residential rate increases over the last three years.
- 3. Public Works (Street, Sanitation, etc.) Council Member Johnny shared a praise of the Sanitation Department from a resident who appreciated the department's quick work during the Spring Clean-Up.
- 4. Tourism (Parks & Recreation, Airport, etc.) Council Member Clint Hollingsworth praised the Chamber of Commerce's successful 2nd Friday summer events. Airport Director Ben Harrison reported on the airport's upcoming hangar, taxiway and apron projects.
- 5. General Government (Finance, Economic Development, etc.) Council Member Jenny Folsom shared the third quarter financial report showing the city's general revenue is up 7.2% and expenses increased 5.1% due to planned expenses and capital projects. The city's general fund is operating with over eight months in reserve, which is the best financial standing in the last 20 years. Cullman County's unemployment rate is 2.5%.

East Elementary's archery team was recognized for their successful season with finishing first place at all nine regular season tournaments, won the regional competition and the state title in the bullseye competition; further they earned first place in 3D and fifth place in bullseye at the NASP Eastern Nationals, qualifying the team for the Championship 'World' Tournament, and where several archers achieved personal best scores, the team earning a second place in 3D and third place in bullseye. Team member, Trevor Bone, was one of 29 archers in the nation to be recognized for the All-American Archery Team.
