## Adopting Transportation Plan Pursuant to the Rebuild Alabama Act

WHEREAS, the Alabama legislature in Act. No. 2019-2 adopted the Rebuild Alabama Act; and

WHEREAS, the Rebuild Alabama Act provides for an allocation among the municipalities of the state on the basis of the ratio of population of each municipality to the total population of all municipalities of the state a portion of the additional taxes levied under the Act to be used for transportation infrastructure, improvement, preservation and maintenance; and

WHEREAS, the Act provides that the municipal governing body of the City of Cullman, Alabama, shall adopt an annual Transportation Plan, no later than August 31, which shall provide a detailed list of projects for which expenditures are intended to be made in the next fiscal year and shall be based upon an estimate of the revenues anticipated from the fund in which the additional revenue is deposited during the next fiscal year; and

WHEREAS, the Act further provides that any such funds shall be used only for the maintenance, improvement, replacement, and construction of roads and bridges maintained by the City of Cullman, Alabama, and such other uses as are defined in the Act; and

**NOW, THEREFORE, BE IT RESOLVED, by the City Council of Cullman, Alabama, as follows:** 

- 1. The City Council of Cullman, Alabama, hereby passes this Resolution as its Transportation Plan submitted in compliance with the Rebuild Act, Act No. 2019-2.
- 2. Pursuant to the Act, the City Council of Cullman, Alabama, estimates that its anticipated allocation from the Rebuild Alabama Act fund for the first fiscal year will be approximately \$112,328.51, with increasing allocations for each fiscal year thereafter.
- 3. Pursuant to the Act, the City anticipates expending funds received pursuant to the Act, in part or in whole, to fund any of the following listed projects:

The City Clerk is hereby authorized and directed to establish a separate fund maintained by the City of Cullman, Alabama, for receipt and deposit of funds received pursuant to the Act, the proceeds of which shall be expended solely for the maintenance, improvement, replacement and construction of roads and bridges maintained by the City and such other uses as are authorized by the Act.

WHEREAS, officers assigned to the CID and designated as on-call shall receive an additional seventy-five cents (\$0.75) per hour; and

**WHEREAS**, this on-call compensation shall be administered under the policies and procedures of the Cullman Police Department and shall not exceed the established number of eligible CID positions as determined by department leadership; not to exceed a maximum of 6; and

THEREFORE, BE IT RESOLVED by the Cullman City Council that the on-call compensation policy for eligible members of the Criminal Investigation Unit is hereby adopted and shall become effective for the pay period beginning on October 22, 2025. WHEREAS, the City Council recognizes the importance to the community and Communications as a whole to encourage continued supervisory participation in the CTEP to provide experience, guidance, and leadership to the recruit telecommunicator so that he or she may become a professional and productive solo telecommunicator employed within the City Communications Department; and

WHEREAS, those telecommunicators who actively participate in the CTEP, not to exceed a maximum total of six telecommunicators, shall receive an increase in his or her hourly wage by seventy-five cents (\$0.75) per hour; and

WHEREAS, the supervisor who actively coordinates and supervises the CTEP, not to exceed a maximum total of one supervisor, shall receive an increase in his or her hourly wage by one dollar (\$1.00) per hour; and

WHEREAS, the Certified Training and Evaluation Program shall be conducted under the policy of the Cullman Communication Department, or as amended hereafter by the Department; and

WHEREAS, the City Council desires to provide a formal pay incentive for firefighters who achieve the National Registry Certification of EMT and PEMT, and further maintain that by obtaining the required continuing education units each year and recertifying every two years; and

WHEREAS, the City Council recognizes the importance to the community and employees of Cullman Fire and Rescue as a whole to encourage the pursuit of occupational related certifications within Cullman Fire and Rescue which is a benefit to the public health, safety and welfare of the citizens in the community; and
