Council President Jenny Folsom called the Cullman City Council Meeting to order at 7:00 p.m. on Thursday, October 30, 2025. Police Chaplain Joe McNulty presented the invocation and led the Pledge of Allegiance.

A roll call by City Clerk Wesley Moore reflected the following: Present - Mayor Woody Jacobs, Council President Jenny Folsom, Council Member David Moss, Council Member Brad Smith, and Council Member Clint Hollingsworth. City Clerk Wesley Moore was also present. Absent: Council President Pro Tem Johnny Cook and City Attorney Roy Williams.

REPORTS OF STANDING COMMITTEES
