

WHEREAS, City of Cullman acting by and through its City Council proposes to apply for a Community Development Block Grant (CDBG) - Economic Development Grant and an Appalachian Regional Commission (ARC) Grant to extend sanitary sewer service R.E. Garrison Trucking.

THAT, WOODY JACOBS, MAYOR, is hereby authorized to execute and submit an application with appropriate assurances to the State of Alabama, Department of Economic and Community Affairs, requesting Fiscal Year 2026 CDBG Economic Development Grant Funds in the amount of \$500,000.00 and ARC Grant funds in the amount of \$500,000.00 to extend sanitary sewer service to R.E. Garrison Trucking.

THAT, THE CITY OF CULLMAN will provide a local match of \$178,774.00 in support of this project.
