**WHEREAS**, City of Cullman was awarded a \$200,000.00 Community Development Block Grant (CDBG) and a \$500,000.00 Appalachian Region Commission (ARC) grant to implement a CDBG Economic Development Project to construct improvements and resurface a portion of County Road 222 from I-65 to the Topre Manufacturing facility on County Road 222.

**WHEREAS**, the City of Cullman has completed the construction phase of this project and is in the process of closing this project out with the Alabama Department of Economic and Community Affairs (ADECA).

**WHEREAS**, ADECA has requested the city submit a formal amendment request removing engineering services from the approved budget and to remove Cullman County from the sources of local matching funds provided in support of this project.

**NOW, THEREFORE, BE IT HEREBY RESOLVED**, that the Cullman City Council authorize Mayor Woody Jacobs to submit a formal amendment request to ADECA removing engineering services from the approved project budget and removing Cullman County as a source that provided local matching funds in support of this project.
